

2023: CPD AUSTRALIA / NZ

Victoria (VIC):

Consumer Affairs Victoria doesn't have a CPD requirement for Real Estate agents. However REIV members have a requirement to complete activities that support professional development including those that: extend your real estate related skills, knowledge and understanding; support the operation of compliant and responsible real estate business and demonstrate your contribution to the overall development of the real estate sector.

Relevant activities will be assigned an REIV CPD hours value. This may include some compulsory training each year.

The REIV Board has set a minimum requirement of 10 CPD hours in each CPD year, 1 April – 31 March. Of the minimum 10 CPD hour requirement, 5 CPD hours may be accumulated through relevant activities undertaken outside the REIV.

New Zealand (NZ):

You must complete 20 hours of CPD each year by 31 December. This consists of: 10 hours of verifiable training delivered by approved training providers, and 10 hours of non-verifiable training on sector related topics.

Queensland (QLD):

There are no current requirements for yearly CPD for Salespersons or fully licensed Agents. REIQ Board has set a requirement of 100 points, 5 points

Western Australia (WA):

All real estate agents and business agents, sales representatives and property managers are required to participate in the program and acquire 10 CPD points (3 mandatory and 7 elective points) by 31 December per calendar year.

Australian Capital Territory (ACT):

A Class 1 Agent in Real Estate or Strata Management must complete at least 9 hours of CPD activity each year, including: 3 hours of compulsory CPD topics applicable to your licence category, 3 hours of elective CPD topics, and. 3 hours of business skill topics.

New South Wales (NSW):

AREC content is an important part of a Real Estate Agents ongoing learning although it is no longer considered part of CPD training. Licensees-in-Charge are required to develop and maintain a training plan for all employed agents, and AREC would be a recommended part of this training plan.

You must complete 4 hours of training on compulsory topics relevant to the class of licence you hold each CPD year. Those 4 hours of training must include at least 3 compulsory topics relevant to your area of practice. This is an increase from 3 hours of compulsory topics required in previous years.

Compulsory topics must be delivered by a training provider approved by the Property Services Commissioner. Compulsory topics must be delivered in: a face-to-face interactive training environment - maximum 40 attendees, or an interactive webinar - maximum 25 attendees, and include an assessment activity. If you are unable to complete 4 hours of CPD training in an interactive environment, you may complete a minimum of 10 hours of CPD by online modules as an alternative. This must include all compulsory topics relevant to your licence category, plus your choice of other training to make up a total of 10 hours. Licensees-in-charge must have all CPD training detailed in the training plan for the agency, and this may be made up of topics most relevant to you.

Tasmania (TAS):

Real Estate Agents must complete 12 points of CPD training. 8 points must be from the industry. 4 points from an external provider.

South Australia (SA):

There are no current requirements for yearly CPD for Salespersons or fully licensed Agents.

Northern Territory (NT):

There are no current requirements for yearly CPD for Salespersons or fully licensed Agents.
